September so that industry fellows can share insights for upcoming students and fellowship candidates.



## **Application Timeline**

- Initial phone interviews will be offered to eligible candidates on a rolling basis after a CV, a letter of intent, and 1 writing sample are received
- Video interviews will be scheduled with competitive candidates on a rolling basis following phone screening
- Competitive candidates will be asked to complete a writing test
- Virtual final interviews will be held in early January on a rolling basis, during which candidates will be asked to deliver a presentation to staff
